**MEMBERSHIP ENROLLMENT:** I want to join my fellow employees and become a member of Montgomery County Community College Faculty Federation, AFT/AFT-PA/AFL/CIO - Local 4272. I hereby request and voluntarily accept membership in MCCC Faculty Federation Local 4272, and I agree to abide by its Constitution and Bylaws. I authorize Local 4272 to act as my exclusive representative in collective bargaining over wages, benefits and other conditions of employment.

**DUES PAYMENT AND DEDUCTION AUTHORIZATION:** I hereby request and voluntarily authorize my employer to deduct from my earnings and remit to Montgomery County Community College Faculty Federation, AFT/AFT-PA/AFL-CIO – Local 4272 an amount equal to the dues percentage and cap uniformly applicable to the members of my union, regardless of whether I am or remain a member of the union. I understand that union dues will be 1.428% of my salary with a cap of \$496.00 per year or such percentage or cap as may be hereafter established by the MCCC Faculty Federation, Local 4272 as certified by the Treasurer. I recognize that neither this authorization nor its continuation is a condition of employment. This voluntary authorization shall remain in effect and shall be irrevocable unless I revoke it by sending written notice via U.S. Mail to both the union and the employer with a copy via email to the President of Local 4272 within the period of fifteen (15) days before the annual anniversary date of this authorization. This authorization shall be automatically renewed and is an irrevocable check-off from year to year unless I revoke it during the window period even if I have resigned my membership in Local 4272.
